High Severity Issues

Low Severity Issues and Owner privileges

1. Add `OwnershipTransferred` event

Recommendation:

There is no `OwnershipTransferred` event in Ownable contract, it would be better, if you will add it.

2. Add zero address checking

Recommendation:

There is no zero address checking in functions [transfer](#) and [mint](#). It would be better to check for zero address, for preventing users from losing their funds.

3. Add `Transfer` event

Recommendation:

Please add a `Transfer` event inside your [constructor](#) after adding all the total supply to the `msg.sender` account.
